VI. <u>GENERAL</u>

A. WEST COUNTY SCHOOL DISTRICT UNIFICATION INFORMATION/DISCUSSION

SCOE is in the beginning stage of gathering more information about the possibility of unifying West County School Districts and possibly re-opening El Molino. President Kim Gluch, Board Clerk Don Strand Superintendent Mason met with Christy White who is meeting with school board representatives. Christy White (CPA, CFE, and President of Christy White Brook) is conducting Feasibility Study Interviews regarding Unifying West Sonoma County Union High School District under Hypothetical Scenario 2 and Inclusive of Harmony School District in the Russian River Area.

B. APPROVAL OF THE WORKPLACE VIOLENCE PREVENTION PROGRAM ACTION

Senate Bill (SB) No. 553 is now codified as California Labor Code Section 6401.9, which requires virtually every California employer to implement steps to prevent or respond to workplace violence. Requirements include a comprehensive written Workplace Violence Prevention Plan (WVPP), employee training that allows employees to ask questions and involves the WVPP Administrators in charge of managing the plan, and logging of workplace violence incidents. Cal/OSHA is the enforcing agency for Section 6401.9 compliance.

C. APPROVAL OF RESOLUTION 2023-2024 #4 –SPECIFICATION FOR <u>ACTION</u> ELECTION ORDER

We have three trustees whose terms are expiring in December and are up for reelection for a full four-year term of office. Education Code Section 5304 requires that Governing Boards order elections and identify the process for resolving tie votes. Ed. Code Section 5322 specifies that Governing Boards deliver a resolution known as the "Specification of the Elections Order" to the County Superintendent of Schools and Ed Code Section 5340 requires that school board elections be consolidated with other elections in the County. Resolution 2023-2024 #4 provides for these requirements and is attached for your approval.

D. CONSIDER APPROVAL OF J. FLORY LLC'S CONTRACT DISCUSSION/ACTION

Jennifer Flory is a consultant for many Sonoma County Schools to help with the various mandated school plans that districts need to create. She comes highly recommended and will help Montgomery Elementary School District with our LCAP and the new Workplace Violence Prevention Program.

E. APPROVAL SUPERINTENDENT/PRINCIPAL SEARCH

DISCUSSION/ACTION

SCOE has offered to help Montgomery Elementary School District search for a Superintendent/Principal for the 2024-25 school year. It is recommended that the position be an 80% Superintendent/Principal with a starting salary at \$95,000 with health and welfare benefits. Dr. Mason has offered to be a liaison between MSD School Board and SCOE to support their search.
